NARRATIVE

On 10/2/09 at approximately 2:10 am, Sgt. Todd Gregory was on a special quality of life patrol in the area of Garfield Ave. During his patrol he discovered a loud party at a residence located on that street. Further investigation revealed that underage drinking was taking place at this party. He was then joined by Officers Mark Del Tin and Alisa Martinez. Officers determined that the party was being hosted by the four occupants of the rented home. They were identified as **Paul M. Szamosszegi, Jake A. Fredrick, Colton L. Strano and Jie Li** . All are currently students at Monmouth University. All four were subsequently taken into custody for providing alcoholic beverages to persons underage. Officers found a beer keg and numerous empty and partially full beer cups throughout the home. All four occupants were then transported OTPD for further processing. All four were charged with Providing Alcoholic Beverages to Person under the Legal Age and violating the township noise ordinance. Frederick and Strano were each also issued a township ordinance violation for Consuming Alcoholic Beverages on Private Property While under the Legal Age. All four were later released on a criminal summons. In addition, police issued Township Ordinance violation summonses for Consuming Alcoholic Beverages on Private Property While under the Legal Age to 18 partygoers most of whom were Monmouth University students. All were released at the scene. They are identified as the following:
