The applicant seeks approval to construct a 1-story addition towards the rear of the existing dwelling. Minimum both side yard setbacks required is 25' where 22.7' is proposed. This site is an undersized 80' by 118 ' lot that is occupied by a one story dwelling. The R-4 Zone requires a minimum 90' lot width (80' exists) and a minimum lot area of 10,000 sq. ft. (9,440 sq. ft. exists)

Michael Celler & Vera Esses, Block 22 Lot 7, 324 Roosevelt Ave, Oakhurst, 07755, Zone R-4

The applicant proposes to remove an existing single family dwelling and construct a new single family dwelling, with covered front and side porches, and a covered rear terrace. They are also proposing an inground pool, a cabana with trellis, outdoor kitchen, outdoor shower, 4 air conditioning condensers and 1 generator. It does not meet the required lot width. The Ordinance requires a minimum lot width of 90'. The existing and proposed lot width is 80'.
